# Privacy Policy

## **Introduction:**

## **Types of Information Collected:**

We retain two types of information:

### **Personal Data:**

- This is data that identifies you or can be used to identify or contact you and may include your name, address, email address, user IP addresses. Such information is only collected from you when you voluntarily submit it to us. An example of this may include visitors and/or members submitting enquiries by completing enquiry forms or by submitting email enquiries on services or events. This personal information is necessary enabling us to provide a response with information to the enquiries which you have made.

### **Purposes for Processing Personal Data:**

- We may process Personal Data you provide to us for the following purposes:
  - a) Contacting you in response to information provided by you by way of enquiry or availing of our services.
  - b) Provision of information and services that you have requested.
  - c) To process your membership application or respond to any communication you might send us;
  - d) To send you important information relating to our activities, your membership, changes to terms, conditions, and policies and/or other administrative information.
  - e) to communicate with you about activities, services, events, training courses and news from us related and of possible interest to you.

### **Non-Personal Data:**

- Like most websites, we gather statistical and other analytical information collected on a basis of all visitors to our web site.
